

REGULAR MEETING

June 7, 2010

A regular meeting of the Town Board of the Town of Busti was held on June 7, 2010 at 6:45 p.m., at the Town Administration Building, 121 Chautauqua Avenue, Lakewood, New York with the following members present:

Supervisor Sullivan called the meeting to order with the salute to the flag and a moment of silence was observed.
