REGULAR MEETING June 3, 2013

A regular meeting of the Town Board of the Town of Busti was held on June 3, 2013 at 6:45 p.m., at the Town Administration Building, 121 Chautauqua Avenue, Lakewood, New York with the following members present:

Supervisor Robbins called the meeting to order with the salute to the flag and a moment of silence was observed.

Present at the meeting were: Angelo & Diane Terrano, Judy Shultz, Steve Dahlgren, Wendy Ward, Lori Robbins, Rudy Mueller, Busti-Lakewood Recreation Director Diana Peterson, Attorney Joel H. Seachrist, Lakewood-Busti Police Chief John Bentley.

Judy Shultz noted that the Lakewood Farmer's Market will be using the grass lot that they have used in the past until further notice. It is possible that they may have to use the parking lot for the Town Administration Building, as approved on May 6, 2013, later in the season.

Lakewood-Busti Police Chief John Bentley reported 4,360 incidents to date; also that one full-time and one part-time officer will be leaving the department in the next month and will be replaced.
